

RESOLUTION
OF THE BOARD OF TRUSTEES
COMMUNITY MEDICAL CENTER

WHEREAS, numerous reports and studies authored by the University of Montana, including well respected consulting firms, have independently demonstrated the HELP Act has significantly benefited more than 95,000 Montanans who have received health care coverage as of October 1, 2018, representing 9.3% of our state's population; and

WHEREAS, the HELP Act has improved health outcomes and led to early detection of disease and ensured 7,026 women received breast cancer screenings, averted 2,313 possible cases of colon cancer, provided 28,683 patients with outpatient mental health services, delivered outpatient substance abuse treatment to 7,146 adults, in total 86,995 adults received preventive services from HELP Act benefits; and

WHEREAS, in Missoula County and Ravalli County, more than 15,000* residents representing almost 20% of the population are now receiving health care coverage under the HELP Act, resulting in more than 11,000 preventative primary care visits; and

WHEREAS, hospitals across Montana have seen uninsured rates reduced 48% and more importantly, Community Medical Center has remained financially viable due to the 250% reduction in uncompensated care levels; and

WHEREAS, Community Medical Center has redirected savings from its reduction in uncompensated care into adding greater than twenty new physicians, adding behavioral health practitioners to our primary care offices, built a program geared to address the increasing challenges of substance abuse during pregnancy to include licensed clinical social worker, addiction counselor and two licensed providers to provide medical management during pregnancy, started a pediatric infusion program, pediatric sedation program, started dialysis services, and opened three new after-hours access points for primary care in our service area; and

WHEREAS, health care is the largest source of private sector income in Montana, representing 1 in 5 dollars earned and the second largest source of private sector employment representing 15.6% of the industry total, paying 25% higher than the statewide average; and

WHEREAS, the HELP Act has significantly stimulated Montana's economy according to the University of Montana's Bureau of Business and Economic Research, which reported that as the result of the HELP Act, 5,000 new jobs, \$270 million in personal income and \$500 million in additional economic output has been added to Montana's economy. Additionally, the HELP Act is expected to generate \$1.2 billion in personal income and \$2.6 billion in economic output or new sales; and

WHEREAS, the HELP Act has served as an economic incentive for small businesses unable to provide health insurance by making coverage available for working Montanans and generating \$36 million in state budget savings by using federal funds to pay for state programs, freeing up state tax dollars for other priorities; and


